

LANSFORD BOROUGH
TAX LEVY ORDINANCE
ORDINANCE NO. 2018-02

An ordinance of the **BOROUGH OF LANSFORD**, County of Carbon, Commonwealth of Pennsylvania, fixing the tax rate for the year **2019**.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted,

By the Borough Council of the Borough of Lansford, County of Carbon, and Commonwealth of Pennsylvania:

That a tax be, and the same is hereby levied, on all real property within the Borough of Lansford subject to taxation for the fiscal year 2019 as follows:

Tax rate for **General Purposes**, the sum of **30.00 mills** on each dollar of assessed valuation, or the sum of **300.00 cents** on each one hundred dollars of assessed valuation.

Tax rate for **Debt Purposes**, the sum of **1.28 mills** on each dollar of assessed valuation, or the sum of **12.80 cents** on each one hundred dollars of assessed valuation.

For **Parks & Recreation** purposes, the sum of **0.25 mills** on each dollar of assessed valuation, or the sum of **2.50 cents** on each one hundred dollars of assessed valuation.

For **Fire Protection** purposes, the sum of **1.00 mills** on each dollar of assessed valuation, or the sum of **10.00 cent** on each one hundred dollars of assessed valuation.

For **Lighting** purposes, the sum of **2.81 mills** on each dollar of assessed valuation, or the sum of **28.10 cents** on each one hundred dollars of assessed valuation.

For **Pension** purposes, the sum of **0.50 mills** on each dollar of assessed valuation, or the sum of **5.00 cents** on each one hundred dollars of assessed valuation.



Tax rate for <u>Fire Protection</u>	<u>1.00</u> mills	<u>10.00</u> cents
Tax rate for <u>Lighting</u>	<u>2.81</u> mills	<u>28.10</u> cents
Tax rate for <u>Pension</u>	<u>0.50</u> mills	<u>5.00</u> cents
TOTAL	<u>35.84</u> mills	<u>358.40</u> cents
