

RESOLUTION NO. 2024-16

A RESOLUTION OF THE BOROUGH COUNCIL OF LANSFORD BOROUGH, CARBON COUNTY, PENNSYLVANIA
AUTHORIZING PAYMENT OF CERTAIN OPERATING DISBURSEMENTS THAT MAY BECOME DUE AND PAYABLE
PRIOR TO THE BOROUGH COUNCIL OFFICIAL REVIEW AND

WHEREAS, 8 Pa. C.S.A. Section 1313 of the Pennsylvania Borough Code specifies that the Borough Treasurer shall pay out all monies of the Borough only on the direction of the Borough Council; and,

WHEREAS, certain vendors that provide services or goods to the borough regularly have a billing cycle that will come in right after the regular monthly council meeting or require the bill to be paid prior to the regular council monthly meeting and may charge a late fee or interested charges for payment by the time it is approved for payment in the monthly meeting.

WHEREAS, it is desire of the Lansford of Borough to avoid payment of late fees or interested charges; and

WHEREAS, it is the desire of Lansford of Borough to maintain a good payment history with certain vendors that provide ordinary and necessary goods and services to the borough on a regular basis; and

WHEREAS, only expenditures which have been budgeted will be paid.

NOW THEREFORE, BE IT RESOLVED by the Lansford Borough Council that the following pre-authorization for payment of certain bills be adopted:

1. The Lansford Borough Treasure is authorized to pay the following vendors for the listed purposes by the due date on the bills and prior to submitting the bills to the Lansford Borough Council for approval so long as the expenditure is accounted for in the borough yearly budget and if needed to avoid a late charge:
 - **PPL -Electric**
 - **Verizon- Telephone**
 - **WEX Bank- Vehicle Fuel**
 - **Water/Sewer Authority- Utilities**
 - **Card Services- Dues & Fees/Office Supplies**
 - **Pen Tele Data- Communication**
 - **Fegley Oli- Garage Heat**
 - **FP Mailing Solution- Office Equipment**
 - **ADP- Payroll Fee**
 - **NAPA – Equipment Repairs**
 - **Jim Thorpe Neighborhood Bank- Loan Payment**
2. Salaries and wages of employees of Lansford Borough, Federal, State, and Local Payroll taxes, unemployment compensation taxes, and payments due for other payroll deductions.
3. Expenses for mailing postage, monthly cleaning, insurance, petty cash reimbursement, and fees payable to the District Court or other courts for enforcement purposes.

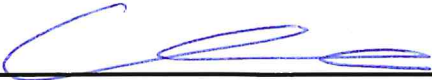
4. At the next scheduled monthly meeting following payment of any invoices or statements paid pursuant to this Resolution, the Lansford Borough Treasurer shall submit all such expenditures to the Council for ratification.
5. This Resolution shall take effect and be in force immediately upon its passage and approval.
